Existing: Ivey shared that she will be meeting with Nifco KTW to discuss some future plans next week. Ivey made introductions to North Georgia Technical College's Adam Fulbright and several of our existing industries. Ivey took GDEcD's new Region 2 Existing Industry Rep, Brandon Lounsbury, to ASI and showed him around our community. Product Development: Ivey shared that the lunch we provided the County's Road Department was well received. Ivey reported that we still need DCA to provide the median average wage we have to use for the lift station grant.
