Ivey visited Project Pharma site and learned they intend to start hiring in August. Project Spring has no new updates. Project Talullah is seeking a property for a salvage antique store. He has visited multiple sites in Toccoa. Project Wire has held meetings with Kinetic and TruVista. Ivey reported a developer is seeking a PUD off memorial drive for potential residential and commercial space. Existing: Pak Pro's owner is trying to set up a meeting with the Mayor and City Manager. Ivey attended a meeting with ASI & Ga Power regarding power outage issues within their facilities. McCraney shared they have been on site and are working with ASI on power quality plans.
